Africans are making their mark as Nigerian, Ugwem Eneyo (CEO, Solstice Energy Solutions) recently won Berkeley's Cleantech University Prize. Her clean energy startup's internet-connected devices help African homes and businesses manage energy efficiently and find clean, money -saving alternatives.

Similarly, a Ca pe Town, South Africa-based music-streaming service, NicheStream, won the PeaceTech Accelerator based at the United States Institute of Peace in Washington D.C.

They exemplify skill, dignity in labour, perseverance and above all, a penchant for disruption. Allow me introduce to you my four favourite SMEs for this Quarter:

- 1- Imagine getting fresh, organic produce and other locally-sourced food delivered right to your doorstep. Tomi Oki is offering just that to residents of Lagos-Nigeria (for starters), through her new business, Fresh to Dommot, which we can describe as 'Freshon-Wheels'!
- 2- **Doctoora's** Debo Odulana is a medical entrepreneur who was once an attending physician, but now choosing to confront healthcare from an unfamiliar angle - providing the public with access to a network of professionals via the ubiquitous mobile phone. Futuristic.
- 3- The Human Resources (HR) technology landscape is exploding with growth and innovation. And **Talent Base** has tapped into this HR-cloud-tech fusion to promise SMEs across Nigeria that its own unique automation of the HR hiring and management process will be far more affordable than – and as effective as - the competiton.
- 4- Medical tourism is a huge drain on Nigeria's resources. What if what we seek abroad can be found in our own backyard, asks Dr. Oluwayemisi Adeyeye (co-Founder, **Lifefount** Hospital)? Read on. This lady entrepreneur is certainly putting her money where her mouth

Fresh to Dommot

Farmed fresh food, cleaned and delivered to your doorstep

rocery is ripe for online disruption, and customers are no longer hesitant to let others pick their produce.

In comes Tomi Oki who is jumping into the country's ultra-competitive grocery market with her new business, Fresh to Dommot, which she says you should think of as your personal fresh foods shopper. By the way, 'dommot' is pidgin English, roughly translated to 'door mouth' or more correctly, 'dooorstep'.

On the Fresh to Dommot website, shoppers can browse and purchase anything from produce to fresh meat to dairy products. Order before 6pm, and the products are delivered to the customer's door the next day. The website also allows shoppers specify prepping instructions

"We are convenient", says Tomi. "Our groceries come to you already prepped. This means you spend a lot less time in the kitchen. I came home one night at 8pm and needed to cook. I simply grabbed a frozen pack of assorted meat from the freezer (yes I use freshtodommot as well), added some seasoning, and that was it."

But hear the rest of her intriguing story.

"I have always loved to cook and I seem to have a taste bud for fresh food, but the stress that goes into prepping groceries for Nigerian dishes is out of this world.

Take "efo" (green vegetable) for instance, you need at least six washes to get the sand out. On the contrary, when you buy vegetables abroad, it is sometimes labeled as "triple washed" giving you an idea of how clean it is. It's therefore a very rude culture shock for someone who just moved back to Nigeria to go through the popular sand-removing ritual for vegetables. At Fresh to Dommot, we do the buying (we are tough price negotiators) and the prepping (sorting, cutting and washing). All the customer does is cook!

However, it took a few years to birth freshtodommot and even longer to start operations. I am customer centric, and I have an eye for fresh food, and the tenacity required to negotiate prices. All these skills I learned from my mother, right from childhood. Yet, one of the major challenges I faced was duplicating the skills with my team. Once this hurdle was overcome, however, we just kept going.

Today, we can confidently say we are a thoroughly customer-focused business. Our customer service policies were designed to make sure that we never lose a customer and it's worked so far. We have a 100% customer retention

Do things go wrong? Yes. When that happens, we rather focus the customer experience. It's crucial. We have a full refund policy, where if the groceries delivered do not meet the customer's expectations, they get to keep the supply and also receive a refund of the full invoice value - or we replace the item with another one.

ounded by Chika Uwazie, Talent Base is a low cost, cloud-based Human Resources (HR) software that efficiently runs personnel management tasks such as payroll, tracking staff development with KPIs and performance reports, planning work shifts, tax automation, expenses and leave management.

It has been described by users as touching on practically every aspect of personnel management from "hire to retire" – and providing all the tools that an SME needs to track and manage employees.

For growing businesses across Africa, TalentBase promises affordability and ease of use, and could possibly become a more attractive and accessible HR solution than pricier alternatives.

The great news is that Ms. Uwazie is currently one of the 44 start-ups selected for the 2017 500 Startups Seed Program, which will see the latter invest \$150,000 in exchange for 6% equity in each start-up.

Headquartered in Silicon Valley (California), and with over \$330M in committed capital across four main funds and 13 micro funds.

One of the only Africans and black women on the program, Ms.Uwazie's vision is to dominate the HR space by continuing to solve a real problem: enabling SMEs hire smarter, and manage faster.

Medical Toruism

he Sovereign Investment Authority of Nigeria recently told the World Economic Forum that 30,000 Nigerians spend \$1 billion annually on medical tourism. 60% is spent in four major areas of healthcare: cardiology, orthopedic, renal dialysis issues and **cancer** (May 22, 2014).

As a journalist with a focus on entrepreneurship, I am looking here at a huge opportunity for healthcare providers in Nigeria to create wealth by strengthening local capabilities.

Dr. Oluwayemisi Adeyeye, CEO and co-Founder of Lifefount International hospital, sees the opportunity.

Based in Ilorin (Kwara State of Nigeria), she is already working with her team to reverse the medical tourism trend, and replace it with what she calls "domestic tourism" - which means patients could travel from Lagos to Ilorin to undergo major procedures for far less than a trip overseas would cost.

Hear Dr.Adeyeye: "In our move to reverse medical tourism, Lifefount international hospital has a tourism package in which patients from anywhere can access affordable and expert healthcare in the serene environment of Ilorin city. There is no need to travel abroad, as we handle various major (and the most minor) interventions. We have partnerships with great hotels, and excellent transport service providers that give our clients an amazing experience while they are with us. Our post- follow-up is excellent."

At a December 2016 meeting of the Nigeria-America Medical Foundation (NAMFI), Nigeria's Minister of Health, Prof. Isaac Adewole, had similarly expressed concern over the huge capital spending on medical tourism by Nigerians, saying: "The Federal Ministry of Health is embarking on rehabilitation of our Federal Tertiary Health institutions to world class standard. "We are also restoring radiation oncology services by revamping radiotherapy machines in the country so as to reduce the migration of cancer patients. "Our referral system will be improved with the revitalisation of Primary Healthcare services (10,000 Primary Health Care centers will be made operational in the next few months)"

While government is much slower to act, Nigerians can perhaps count on the more nimble service of private sector healthcare providers like Dr. Adeyeye, who have already improved access to affordable health services by investing in infrastructure, talent development, high quality, specialised care, lowered costs, reduced waiting times, and international collaborations,

Dr. Adeyeye is an alumna of the Tonly Elumelu Entrepreneurship Foundation (TEEF) program, and a beneficiary of the Cherie Blair/ Exxon Mobil 'Road to Growth' business education at the Enterprise Development Centre of the Pan African University. Her vision for Lifefount hospital is to be among the top five surgical centres in Africa.

Dear Dave, I have just moved into our small family house, and I want to use solar security and gate lights. How will I know which ones to buy? What specifications? What else do I need to know?



: Dear Shade, thank you for writing A good place to start will be at

some of the popular online stores. You can find plug-and-play units that will meet your basic security lighting needs. Some features or specifications to look for in plug-and-play units include:

- The built in battery capacity usually stated in milliampere hours (mAh)
- Brightness rating usually stated in Lumens (450 – 900 lumens is typical)
- · Power rating stated in Watts
- The expected lifespan of the lighting unit in hours (10,000 – 50,000 hours) typical
- Beaming angle, which differentiates spot lighting from wide angle beams

Warranty information and return policy (for repair or return issues)



A functional plug and play security light in 2017 should cost no more than N15,000.00 per unit and would come with a solar panel included (typically in the 5 – 10 watt range).

It is important to note that your plug and play solar lights are largely maintenance free, but require solar panel surfaces to be wiped clean occasionally with a soft dry cloth. Dust or debris accumulation on your lighting panels can impede proper battery charging, which may result in lights not lasting through the hours of darkness.

Most solar powered lights have sensors which automatically turn the unit off at

TAX DUE DATES In Nigeria

s an entrepreneur in Nigeria, the knowledge of tax due dates can aid in planning your processes for tax remittance. Tax Due Date is the statutory date required for a particular tax type to be remitted or filed. And the Federal Inland Revenue Service (FIRS) is the agency saddled with the responsibility of ensuring taxpayers remit and file their taxes as and when due. FIRS also enforces penalties where there are tax defaults. Under the current self-assessment regime, taxpayers are required to compute their tax liabilities, and file and make payment concurrently, on or before the due dates. Any breach is liable to fines and interest, as prescribed under relevant laws. The tax types in Nigeria, statutory due dates and penalties are highlighted below:

Pay-As-You-Earn (PAYE): PAYE is a method of collecting personal income tax from employees' salaries and wages, through deduction at source by an employer as provided by the relevant sections of the Personal Income Tax Act (PITA)². PAYE is to be remitted by an employer on behalf of his/her employees after deducting the appropriate amount of tax from the employee's monthly salary. This deducted tax is to be remitted not later than 10 days after the end of the month for which the tax was deducted i.e. the 10th of the succeeding month after the month wherein the deduction was made³. Annual returns however, must be filed with the relevant tax authority not later than 30 days after the end of the year of assessment - this is usually taken as January 31st of the succeeding year⁴.

Failure of the employer to deduct or remit deducted tax to the relevant tax authority as stipulated by tax regulations attracts a penalty of N5,000.00 on conviction and N100 for every day in which the failure continues in addition to the principal

amount to be remitted⁵. For late filling of annual returns, the penalty is N500,000.00 for corporate bodies and N50,000.00 for individuals upon conviction.

Personal Income Tax (PIT): PIT is a tax imposed on individuals who are either in employment or are running their own small businesses under a business name or partnership. Though collection of PIT is a Federal responsibility, this tax is generally collected by state governments from those that are resident in their various states, regardless of whether they are Federal, State, Local government, or Private sector workers⁷. The due date for filing PIT is 90 days after the end of the year, this is usually taken as 31st March of the following year⁸. The penalty for late filing of PIT is the same as outlined for PAYE⁹.

Value Added Tax (VAT): VAT is a tax on consumption. It is a flat rate of 5% and is borne by the final consumer of goods and services in Nigeria 10. VAT returns are to be rendered on or before the 21st day of the Month following that in which the sales/ supply was made 11. A taxable person who fails to remit VAT returns as stipulated is liable to a fine of N5,000 for every month in which failure continues 12.

Withholding Tax (WHT)

A withholding tax is a tax required by Law to be withheld by a party from each payment made to another contracting party from the income or services rendered 13. WHT is to be remitted on or before the 21st day of the Month following that in which the sales/supply was made. Failure to deduct or remit after deduction attracts a penalty of 10% of the amount of tax to be deducted in addition to the amount itself plus interest at prevailing rate 14.

Company Income Tax (CIT):

Companies in Nigeria are mandated by Law to pay company income Tax (CIT) based on profits. The amount charged is 30% of profit_earned in the year preceding assessment 15. According to CIT regulations, any company that has been in existence for more than eighteen months is required to file returns every year not later than six months after the end of its accounting year ¹⁶. For a new company, returns are expected to be filed within eighteen months after the company is incorporated or not later than six months after the end of its first accounting period; depending on which is earlier. Late filing of CIT attracts a penalty of N25,000.00 in the first month of failure and N5,000.00 for each subsequent month¹/.

Education Tax (EDT): EDT is a tax chargeable on all companies registered in Nigeria at 2% of chargeable profits as contribution to the Education Tax Fund . EDT is computed when assessing companies for CIT/PPT and is a part of the tax computations when filing CIT or PPT returns. Its due date is the same as outlined for CIT/PIT

National Information and Technology Development Levy (NITDL): According to the NITDL Act, companies are assessed for NITDL while being assessed for CIT/PPT in an accounting period. NITDL is thus part of the tax computations for applicable

companies when filing returns for CIT/ PPT²⁰. NITDL is charged at 1% of profit before tax. The due date for NITDL is the same as due date for CIT/PIT and the same penalty applicable to late filing of CIT/ PPT also covers NITDL. Companies with a turnover of N100,000,000 engaged in the following business lines are assessable to NITDL:

- a. GSM service providers and all telecommunication companies;
- b. Cyber companies and internet providers;
- Pension managers and pension related companies;
- Banks and other financial institutions
- Insurance companies

Petroleum Profits Tax (PPT): Petroleum Profit Tax is tax that is charged on income accruing from petroleum operations and is peculiar to companies involved in petroleum operations. The PPT Act stipulates that an estimated return should be filed not later than two months after the commencement of the accounting year which is different from others that are filed at the end of the accounting year. The Act also states that if at any time during any such accounting period, the company having made a return in the period disclosed above is aware that the estimate in such returns requires revision, then it shall submit a further return containing its revised estimated tax for such period² At the end of the accounting year, a final tax return is expected to be filed not later than five months after the accounting year end²³. Failure to file returns as stipulated by the Act attracts an initial penalty of N10, 000 plus N2,000 for every day the failure continues²⁴.

Capital Gains Tax (CGT): This is the tax imposed on the gains made from the disposal of an asset such as a house, vehicle, machinery etc and is charged at 10%. The due date for filing CGT according to the CGT Act is the last day in that year of assessment²⁵. It should however be noted that individuals will file CGT returns with the relevant State Board of Internal Revenue while companies will file with the FIRS.



yet the Band Plays On

ommon sense must always prevail - especially when it comes to customer service. That said, sometimes companies create strict rules and policies or have a "system" that makes it impossible for an employee to deliver the customer service the company actually wants them to deliver.

Recently, I was sitting next to someone on an airplane who was on his way to a vacation on a cruise ship. We got into a discussion about how some people are so set in their ways that they can't be creative about solving a customer's problems. These people are so tied to their process and the way they have always done things that they jeopardise the relationship with their customer, even when common sense should prevail.

The Case of the Titanic


My fellow passenger has been on many cruises – and as good as the customer service is on most cruises, he said there are always a few of the ship's employees that are more focused on the system or process than on their customer. He then shared a few stories from his past trip about how some crew members lacked common sense. For some reason, it reminded me of the Titanic and how the eight-member band continued to play, even after the ship started sinking.

I thought that the story of the band playing while the ship was going down might be fictitious, so I did a little research to see if were true. Well, as the story actually goes, the reason for the band continuing to play was that Wallace Hartley, the band's leader, had asked the band to keep playing because he thought it would help calm the chaos that was ensuing around them.

Common Sense

Maybe that was true, but I'd like to take some creative license and bend this story a bit to create a customer service lesson. My made-up version of the story has nothing to do with keeping the passengers calm. My version is that Mr. Hartley said, "Keep playing. We still have two hours to go in our set." The passengers had all left to save themselves, but the band played on ... as they went down with the ship.

The point is that Mr. Hartley's band should have stopped playing immediately and tried to save themselves. Common sense should have prevailed. The band should have headed for the life rafts. But, sometimes people just do what they think they are supposed to be doing, without regard for common sense.



So, what does this have to do with customer service? The best companies hire smart, problem-solving, customer-focused people who look for ways to work around having to say NO and come up with ways to say YES. They don't get stuck on company policy. They work within the rules, but also understand flexibility. They will do what's right for both the company and the customer. In short, they use common sense, especially when the ship is going down - or a customer is angry.


